Who we are, how we work, what we offer

What is the Consumers Energy Cooperative (CECI)?

CECI is a member owned not-for-profit corporation established to provide home heating oil and to offer a burner service contract.

When and who founded CECI?

CECI was founded in 1981 by members of the Pace University Academic Credit Union.

Why join CECI?

- **Big savings**

Members have saved substantially in home heating bills. CECI's prices for fuel oil are usually at least 10 cents per gallon below the daily published average retail price for #2 home heating oil listed in the *Journal of Commerce*. CECI saves by paying its bills within 10 days, and providing its dealers with the logistical paperwork for them to make deliveries to our members. (The dealer's delivery ticket to members is not an invoice.)

- **Great service**

All of our suppliers are full-service dealers. Each fulfills the needs of hundreds of our members. Our size gives us leverage when advocating for our members and when seeking the best possible service. We offer a burner service contract which has provisions for off-hour emergency service. Please read the Service Contract (see our Website) for details. Certain fees do apply. We also offer a hot water burner service contract.

- **Member rebates**

CECI strives to rebate annually any excess revenue collected during its fiscal year. The account of each member in good standing is credited an amount computed using a formula that is in part proportional to the member's total oil purchases for the year.

- **Low interest repair/replacement loans**

CECI offers low interest loans to members in good standing a year after joining. Loans are for upgrading tank installations and/or replacing heating systems. Call the office to discuss loan options.

Commitments you make when joining

To be a member in good standing, you agree to the following terms:

- Buy a minimum of 500 gallons of fuel oil annually and buy fuel exclusively through us
- For the Budget Plan, submit the coupon and payment at the beginning of each month.
- Maintain a fuel tank deposit (minimum balance)
- Pay all invoices within 7 days of receipt
- Keep us informed about changes that might affect your account or your oil usage

Membership fee: \$20.00 per year

Minimum Balance

Members must **choose one** of three **payment plans:**

Option 1: BILL-AS-RECEIVED PLAN

Delivery: Either CECI estimates when deliveries should be made or you call to schedule a delivery.

Minimum Balance:

Payment: Invoice must be paid within 7 days. No invoice is generated if you have sufficient funds on account to pay your balance due.

Option 2: BUDGET PLAN

Delivery: Either CECI estimates when deliveries should be made or you call to schedule a delivery.

Payment: If deposits and prepayments do not cover the cost of deliveries, you will be invoiced and you must pay within 7 days.

Option 3: PREPAY (or CASH) PLAN

Delivery: You schedule all deliveries and you pay CECI five business days in advance of each delivery.

Minimum Balance: None

Payment: Fuel deliveries are scheduled only after payment has been made.

In order to enroll you in the cooperative, we ask you to provide us with information about you and your heating system. This information allows us to create an account for you and lets you determine how much your initial payment to us will be. **If you cannot answer any of the questions, please call us at 914-941-2288 and we will help you, or return the incompletely filled out form.** We will review your application and call you if we have any questions about the information you have supplied. (If you have multiple burners, you must buy a service contract for each burner to be covered.)

Please note: We do not offer a plan that guarantees that you will never run out of oil. While run-outs are rare, they do occur occasionally. We encourage all homeowners to learn how to read the oil gauge on their tank, and to regularly read the gauge, especially during the heating season.

The **first** step is to tell us the size of your fuel tank. If you have multiple tanks connected together, fill in the total capacity.

The **second** step is to select the payment plan that best suits your needs. Your choices are the Bill-as-Received plan, the Budget plan, or the Prepay (also called Cash) plan. These plans are described in the information packet we provided. Place a **check** in the box for the payment plan you are selecting. After reviewing the terms of the service contract, **fill in the remaining blanks** for your plan with the appropriate amounts. When you mail in your application to CECI, include a check for the amount you compute as your total.

The **fifth** step is to tell us if you prefer to have CECI schedule oil deliveries automatically (called “automatic delivery”) or if you prefer to call us to arrange for a delivery (called “will-call”). Check one of the two boxes.

For **Automatic delivery check** here →

Under “automatic delivery” we estimate when each delivery should be scheduled and we schedule each delivery. “Automatic delivery” does not mean that we guarantee that you will never run out of fuel. Since your actual usage of fuel is completely out of our control, we can not anticipate with complete confidence when you should receive fuel. (Not available for Prepay/Cash plan.)

For **Will-call** check here →

Under “will-call” you are solely responsible for determining when oil should be delivered and you must submit your request to CECI far enough in advance that CECI has up to five business days to make the delivery.

The **sixth** step is to read, understand and agree to a set of legally binding conditions.

I hereby apply for membership in Consumers Energy Cooperative Inc., a cooperative owned by its members and managed by its member-elected Board of Directors. I understand that I will buy fuel oil exclusively from CECI, and that I will notify CECI in a timely manner when changes occur that might affect my consumption of fuel. I agree to abide by CECI’s bylaws, to pay the non-refundable annual membership fee, and to maintain a minimum balance in my account (as prescribed) which may be used to pay any account deficit, and to take delivery of a minimum of 500 gallons of oil per year. I further agree to pay all invoices in full within 7 days of being billed whenever my account balance falls below my Minimum Balance amount. I understand that I may be charged a late fee when I fail to pay promptly.

I agree that CECI shall not be held responsible for previously existing problems no matter when such problems are discovered. I agree that, in the event a problem develops involving any portion of my heating/cooling system(s), or any consequential damages from same, that is not explicitly covered by any agreement between CECI and me, my remedy will be against any installers or service providers, and my own insurance, if any. Where applicable, I agree to work with CECI to resolve any problems that arise, and I agree to supply proof that I have exhausted other remedies for recovering losses, and to provide CECI with any pertinent information.

If CECI commences legal action against me to recover an indebtedness to CECI, I shall be responsible for any and all costs and expenses associated with the collection of the indebtedness, including but not limited to legally permitted fees, court costs, and attorney’s fees.

When I wish to terminate my membership I will give a termination notice to CECI in writing. I will do this in a timely fashion so that any special arrangements (such as issuing a request to have the contents of a fuel tank measured for the purposes of creating a statement needed for a house closing) can be scheduled. I can terminate my membership at any time. Following CECI’s receipt of a written termination notice, any account balance, including my Minimum Balance, will be returned to me within 30 days. Such written termination notice shall not affect any right of claim CECI has against me until any and all indebtedness owed to CECI is fully paid.

CECI has the right to terminate my membership for non-payment and/or just cause pursuant to its by-laws.
